

## **Theme: “Be Ready. Be Buckled. – Ready for the Road Ahead!”**

This contest is open to all children between the ages of 5 and 12.

When creating your work of art think about these questions:

- Why is it important to buckle up while driving a truck, bus or other large vehicle?
- What does it mean to you for truck and bus drivers to buckle up while on the job?
- What would happen if a truck or bus driver did not buckle up while on the job?

The subject of the artwork entry is to be the student’s personal expression of the importance of Commercial Motor Vehicles (CMV) drivers buckling up.

### **Criteria:**

1. Entries can be a painting, drawing, collage or other two-dimensional work.
2. For contact purposes only, students must include their name, address, phone number, e-mail address (optional), school and grade on the back of their artwork.
3. All entries must be emailed or postmarked by November 30, 2009.
4. Winners will be recognized at the American Society of Safety Engineers’ (ASSE) North American Occupational Safety and Health Week kick-off events in Washington, D.C., May 3, along with their annual ASSE kids’ “Safety-on-the-Job” poster contest.

### **Participation: Entrants will be divided into two categories by grade:**

- Category A - K thru 2nd grades, as of September 7, 2009
- Category B - 3rd thru 6th grades, as of September 7, 2009
- There will be a total of 12 winners including first place prize winners for each category.

### **Prizes:**

- Two Grand Prizes: National recognition in our Nations Capitol!
- Each student will receive a certificate of appreciation from the CMV Safety Belt Partnership for their entry.
- Student submissions included in the calendar will receive an additional token of thanks.

### **Entry Requirements:**

1. Only one submission per student.
2. Entry may be a painting, drawing, collage, or other 2-dimensional work only no larger than 11” x 17”.
3. CMV Safety Belt Partnership and members reserves the right to copy and modify any entry for reproduction. Entries will not be returned and may be used for future promotional opportunities.
4. Artwork will be judged on originality of design, clarity of theme message, and artistic merit.
5. Deadline for Submissions – November 30, 2009 (midnight).
