Learn About Entry Level Driver Training (ELDT)

ELDT includes training requirements to obtain a first-time Class A or Class B commercial driver's license (CDL), upgrade an existing Class B CDL to a Class A CDL, or get a first-time school bus (S), passenger (P), or hazardous materials (H) endorsement.



Understand the Safety Measurement System (SMS)

The SMS website is a one-stop shop for motor carrier safety data. Access information on licensing and insurance status, safety ratings, and inspection and crash data, along with public Behavior Analysis and Safety Improvement Category (BASIC) data.



Learn About Electronic Logging Devices (ELDs)

Find information and resources for drivers, motor carriers, ELD providers, and enforcement partners. Learn how to comply with ELD rule requirements, test and register an ELD, view the current list of registered ELDs, and more. Enforcement partners may view training materials on ELD exemptions, reviewing HOS data, and more.



Locate FMCSA Notices and Rulemaking Documents

FMCSA provides easy-to-use tools to access FMCSA rules, proposed rules, and notices on the Federal Register website. You can search by keyword, document type, topic, and subject or browse a chronological list.



Check for Drug & Alcohol Violations

The Drug and Alcohol Clearinghouse is a secure online database for commercial driver drug and alcohol program violations. It includes drivers with commercial driver's licenses (CDLs) and commercial learner's permits (CLPs) who are covered by FMCSA's Drug and Alcohol Testing Program. Registered drivers can access their own records at no cost.
