Annual Ethics Training for MRB Members Gregory Miller, Attorney Advisor, General Law Division, Office of Chief Counsel

Mr. Miller conducted annual ethics training for the MRB members, who serve as special government employees (SGEs) under the Federal Advisory Committee Act (FACA). Mr. Miller provided information on how MRB members are evaluated to ensure they can ethically participate as members and suggested ways for them to navigate scenarios that may require a careful consideration of ethics. Should an MRB member question the ethics of any situation, that member should consult with the Agency's ethics official.

PRESENTATION: "EFFECT OF THE LENGTH OF MEDICAL CERTIFICATION ON SAFETY," SUSAN SOCCOLICH, RESEARCH ASSOCIATE, VIRGINIA TECH TRANSPORTATION INSTITUTE

Ms. Soccolich presented the preliminary research findings of a study to assess the relationship between the duration of commercial motor vehicle (CMV) driver medical examination certification (MEC) and driver performance. The study collected historical medical examiners' certificate data, crash data and inspection violation data for CMV and non-CMV drivers' groups from January 1, 2014, to September 30, 2020. Overall findings reveal that shorter MEC lengths show significantly higher relative risk for crashes and driver-only violations during inspections. Multiple types of violations (including vehicle and hazmat) yielded a reverse trend with shorter MEC length associated with lower risk of violations. Based on the research it is premature to conclude that drivers with short term MEC are more likely to have a crash or violation than those with a 24-month MEC. A final report is under agency review and expected to be published in spring 2023.

PRESENTATION: "EXAMINING THE SEIZURE STANDARD FOR COMMERCIAL MOTOR VEHICLE DRIVERS," KURT HEGMANN, MD, MPH PROFESSOR AND DIRECTOR, ROCKY MOUNTAIN CENTER FOR OCCUPATIONAL AND ENVIRONMENTAL HEALTH, UNIVERSITY OF UTAH

Dr. Hegmann presented preliminary findings on the examination of seizure standards for CMV drivers through a systematic literature review and meta-analysis. The study asked seven key questions regarding individuals with or without treatment. Dr. Hegmann's recommendations to the board includes no evidence-based data on which to recommend changes to the current FMCSA seizure exemption criteria. Dr. Hegmann suggests modifying "for 8 years" to "at least 8 years." The regulation could also be clarified for drivers who do not have a current diagnosis of epilepsy or seizure disorder. The final report is undergoing agency review and is expected to be published in spring 2023.

- MRB members raised questions about the importance of type of seizure risk while on treatment and further interest in sleep epilepsy given the 13-31% rate of additional awake seizure occurrence.
- Dr. Harmon raised the question of provoked head trauma not provoked seizures and whether that would require neurologic referral. Dr. Hegmann responded that if it has immediate convulsive activity then could be considered provoked, but if it is delayed then would instead be considered a post concussive seizure with an increased risk of recurrence.

Public Comment:

 Brandon Buchanan, ABA, asked if given the President's announcement on October 6th about changing classifications about some Schedule1 drugs, such as marijuana, would result in MRB considering another look at schedule-1 drugs or medications for the future for both CDL and non-CDL drivers. Mr. Buchanan mentioned that it was approximately eight years ago when the Schedule1 drug classifications were changed.
