# Grant Technical Assistance Webinar 1: How to Apply & Title VI Requirements



### **Topic 1: High Priority Grant**

#### 1. Do you know when the award announcements will come for the HP grants?

# 2. Can a State Agency, who is currently and will continue to be a Sub-Grantee with the lead MCSAP Agency (separate State Agency) apply for a High Priority Grant or other grant opportunities?

#### 3. Is there a personnel limit when applying for the grant?

There are no limits as to the number of personnel an applicant may propose in their application package. Keeping in mind that the applicant's budget narrative should support the number of personnel needed to execute the proposed project.

#### 4. Is feedback provided on the evaluation results of the Grant application?

This will be covered during in-depth during the technical assistance webinars and the NOFO Conference, but in general, each applicant does receive some type of notification about if the application is eligible via email. Letters are also issued for applications that are not recommended for funding.

#### 1. Are there any significant updates from NOFOs in 2023 compared to 2024?

# 2. Should item 8f of the SF-424 be the authorized representative? Or does it vary by NOFO?

The Authorized Representative is the person who has the authority to submit and accept federal financial assistance (grants and cooperative agreements) named in field 21 of the SF-424. The person who is named in section 8f of the SF-424 is the person who the grantor would contact for questions concerning the application content. The person's named could be the same person, dependent upon the entity's resources and delegated authorities.

It does not vary by NOFO, normally.
