

FMCSA GRANT WRITING RESOURCES

Your organization may be eligible for funding!

Each year, FMCSA funds projects to support their mission to reduce crashes, injuries, and fatalities involving commercial trucks and motorcoaches. Many projects, investments and technologies that impact commercial vehicle (CMV) safety are eligible. Goals, criteria, and eligibility differ for each grant program. **Individuals are not eligible**.

Eligible agencies include:

- State, local and Tribal governments
- Universities, colleges, vocational and truck driving schools
- Nonprofits
- Business

- Transportation projects that spur economic growth
