# CMV Awareness Program

The Federal Motor Carrier Safety Administration (FMCSA), International Association of Chiefs of Police (IACP) and Commercial Vehicle Safety Alliance (CVSA) have partnered to develop the Commercial Motor Vehicle (CMV) Awareness Training for officers from state, local and county law enforcement agencies. The purpose of the CMV Awareness Training is to inform patrol officers of potential safety and enforcement issues involving foreignbased CMVs and drivers operating outside the border commercial zones. Presented in 5-20 minute modules, the training has been designed for flexible delivery methods. Future delivery methods will include web based training and a DVD.

This training will provide the basic operating requirements for foreign-based CMVs and drivers that will be useful during a routine traffic stop or in response to a crash. The training will be conducted by a Certified CMV Officer from your jurisdiction. This same Certified CMV Officer might be your point-of-contact should a traffic stop result in a more comprehensive vehicle and/or driver investigation.

Please remember that your traffic stop and careful examination of the foreign-based CMV, its driver and cargo, may prevent a fatal crash or injury on our nation's highway.



## Foreign Commercial Motor Vehicle Awareness Training Program

Understanding the Basic Operating Requirements of Foreign-Based Motor Carriers, CMVs, and Drivers

#### **DID YOU KNOW?**

- Currently there is an acceptable old and new version of the Mexican commercial drivers license (CDL) for operating a CMV in the U.S. and Canada.
- Canada does not issue a separate commercial license. Canada does not issue a CDL like the U.S., but rather issues a "classified" driver license which defines what classes of commercial vehicle a driver may operate.
- Drivers from Mexico and Canada do not have to possess a separate medical certificate, like U.S. drivers, as it is a condition they must meet for their drivers license.





- Officers may see different license plate configurations and documents verifying registration for each state and country.
- Operating Authority is required for most For-Hire, U.S., Canadian, and Mexican motor carriers. Even some private Mexican motor carriers are required to have Operating Authority.
  - The International Fuel Tax Agreement (IFTA) is an agreement among all 50 states, 10 Canadian provinces, and Mexico to simplify the permitting of and reporting of fuel use tax by interstate motor carriers.
    - The CVSA issues Inspection
       Decals when a CMV passes
       a rigorous safety inspection.
       Decal criteria apply only to the
       condition of the vehicle.
      - Cabotage is point to point transportation of goods and passengers in the same country.
