PROCLAMATION

Executive Order

TO ALL TO WHOM THESE PRESENTS MAY COME, GREETINGS:

- WHEREAS, Indiana has experienced severe winter weather and near-record cold temperatures; and,
- WHEREAS, the near record cold temperatures have greatly increased the demand for propane for home, business and public building heating and for agricultural operations; and,
- WHEREAS, approximately 500,000 Hoosiers depend on propane to heat their homes, businesses, schools and other public buildings; and,
- WHEREAS, current demand for propane exceeds locally available supply; and,
- WHEREAS, the lack of available propane has forced drivers transporting propane to drive longer distances in search of propane; and,
- WHEREAS, under 49 CFR 395, incorporated by reference into Indiana statute under I.C. 8-2.1-24-18, drivers are statutorily limited in the number of hours they may operate a commercial motor vehicle; and,
- WHEREAS, long lines at propane terminals throughout Indiana, slow travel due to bad weather conditions, and longer driving distances have caused drivers to deplete available hours of service while either driving or waiting in line, making it difficult to deliver propane to residential customers within the statutorily prescribed time limitations.
- WHEREAS, on January 29, 2014, by proclamation of the Governor, motor carriers and drivers transporting propane in Indiana were exempt from regulations limiting their hours of service until March 1, 2014; and,
- WHEREAS, the conditions that precipitated the January 29, 2014 proclamation continue to persist.

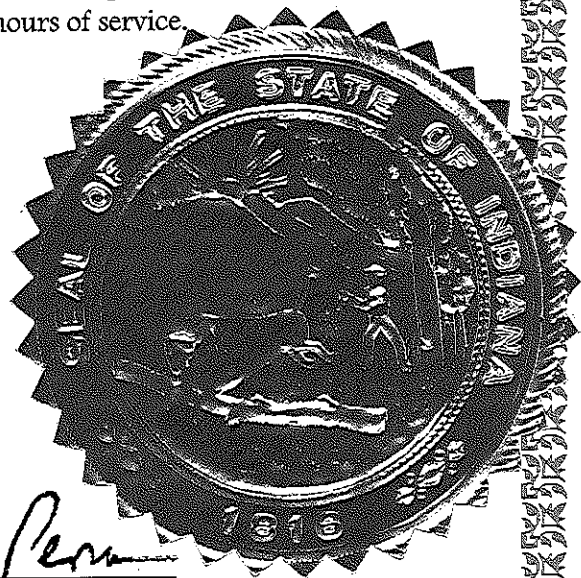
NOW, THEREFORE, I, MICHAEL R. PENCE, BY VIRTUE OF THE AUTHORITY VESTED IN ME AS Governor of the State of Indiana, pursuant to IC 10-14-3-12, do hereby declare that an emergency exists and order that:

1. The January 29, 2014 proclamation exempting motor carriers and drivers transporting propane in Indiana is extended until March 15, 2014. Motor carriers and drivers transporting propane in Indiana are exempt during this emergency from regulations limiting their hours of service under 49 CFR 395, incorporated by reference into Indiana statute under I.C. 8-2.1-24-18. This exemption is effective from the time of the issuance of this order until March 15, 2014, unless otherwise extended or terminated by order of the Governor.
2. Nothing contained in this declaration shall be considered as an exemption from any portion of the Motor Carrier Safety Regulations other than those regulating hours of service.

Executive Order **PROCLAMATION**

WHEREAS, long lines at propane terminals throughout Indiana, slow travel due to bad weather conditions, and longer driving distances have caused drivers to deplete available hours of service while either driving or waiting in line, making it difficult to deliver propane to residential customers within the statutorily prescribed time limitations.

WHEREAS, on January 29, 2014, by proclamation of the Governor, motor carriers and drivers transporting propane in Indiana were exempt from regulations limiting their hours of service until March 1, 2014; and,

NOW, THEREFORE, I, Michael R. Pence, **BY VIRTUE OF THE AUTHORITY VESTED IN ME AS** Governor of the State of Indiana, pursuant to IC 10-14-3-12, do hereby declare that an emergency exists and order that:

1. The January 29, 2014 proclamation exempting motor carriers and drivers transporting propane in Indiana is extended until March 15, 2014. Motor carriers and drivers transporting propane in Indiana are exempt during this emergency from regulations limiting their hours of service under 49 CFR 395, incorporated by reference into Indiana statute under LC. 8-2.1-24-18. This exemption is effective from the time of the issuance of this order until March 15, 2014, unless otherwise extended or terminated by order of the Governor.
2. Nothing contained in this declaration shall be considered as an exemption from any portion of the Motor Carrier Safety Regulations other than those regulating hours of service.
