

**Traffic enforcement for commercial motor vehicles violations is a vital element in preventing crashes—and saving lives.**

- Due to size, weight, and increased stopping distance, commercial motor vehicles are disproportionately involved in traffic fatalities.
- Serious moving violations such as speeding, tailgating, improper lane changes, reckless driving, and driving while fatigued or impaired are the leading causes of crashes.
- Commercial drivers who commit serious traffic violations may also be involved in serious crimes—from moving fraud to drug smuggling to human trafficking.

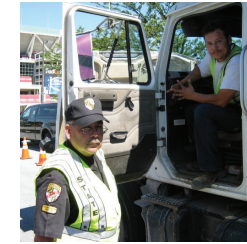
