ELD Manufacturer Registration Process

ELD product vendors will register with FMCSA and self-certify device compliance.

Manufacturer registration

- » Visit FMCSA ELD website: https://3pdp.fmcsa.dot.gov/ELD/
- » Create an account.
- » Provide required information.
- » Add users.

Required information

- **1.** Company name of the technology provider/manufacturer.
- 2. Name of an individual authorized by the provider to verify that the ELD is compliant with Appendix A, Subpart B of Part 395 of the ELD Final Rule, and to certify it under Section 5.2 of Appendix A.
- 3. Address of the registrant.
- 4. Email address of the registrant.
- 5. Telephone number of the registrant.

Registering your device

- » Visit ELD home page and log in to your account.
- » Click on "Register device."
- » Provide details about device(s).
- » Self-certify device compliance.

Required information

- **1.** Name of the product.
- **2.** Model number of the product.
- **3.** Software version of the product.
- 4. An ELD identifier, uniquely identifying the certified model and version of the ELD, assigned by the ELD provider in accordance with Section 7.15 of Appendix A.
- 5. Picture and/or screenshot of the product.
- 6. User's manual describing how to operate the ELD.
- 7. Description of the supported and certified data transfer mechanisms and step-by-step instructions for a driver to produce and transfer the ELD records to an authorized safety official.
- 8. Summary description of ELD malfunctions.
- 9. Procedure to validate an ELD authentication value as described in Section 7.14 of Appendix A.
- **10.** Certifying statement describing how the product was tested to comply with FMCSA regulations.

When vendors modify their products, they must return to the registration site and update information about their product. Depending on the significance of the changes, this may result in new configuration files that vendors will incorporate into their products.

A complete list of self-certified or registered ELDs is available on the FMCSA ELD website.

Removal from the list of self-certified ELDs: If FMCSA finds an ELD does not conform to the rule

» FMCSA will provide written notice stating:

- The reasons FMCSA proposes to remove the model or version from the FMCSA list; and
- Any corrective action that the ELD provider must take for the ELD model or version to remain on the list.
- » Manufacturer has 30 days to appeal or notify FMCSA of corrective actions they will take.
- » Manufacturers will be removed from the list of certified devices if:
 - They fail to reply to FMCSA's written notice within 30 days.
 - They fail to take corrective actions within 60 days of the written notice.
- » Manufacturer may submit a written request for an administrative review within 30 days of removal.

Coming soon: enhanced registration

If you have registered your device(s) already, you will need to return to the website to supplement your registration in order to provide the information FMCSA requires, and to receive the information you need from FMCSA. We will contact you via the email address you provided in your manufacturer registration to let you know when this is available.

If you have not registered on the FMCSA ELD website yet, please do so to ensure that you are included on the update emails when these enhancements are available.
